**4799** safeguarding adult referrals received; a 10% increase compared to 2020/21

**1946** s.42 enquiries undertaken

In **83%** of cases it was recorded that the risk of harm to the adult was completely removed or was reduced

## Safeguarding Adult Reviews

**Thomas:** In November 2021 we published the [learning brief](#) for Safeguarding Adult Review SAR20A.

The Board continue to oversee progress in relation to the recommendations of the SAR.

A Learning from Safeguarding Adult Reviews, Multi-Agency Learning Reviews and Domestic Homicide Reviews' conference took place on 29th April 2021. Over 150 practitioners and managers attended. The conference covered local, regional, and national learning and positive practice in relation to reviews.
