It has been a busy time for the Derbyshire Safeguarding Adults Board, with a Development Session held jointly with Derby SAB on 1st March 2024, followed by a Derbyshire SAB Board meeting on 16th May 2024.



We have now agreed our Strategic Plan for 2024-2025, which sets out the direction of our Board, along with our strategic aims and objectives. You will see that we have agreed four strategic priorities:

1. Making Safeguarding Personal
2. Prevention
3. Quality assurance
4. Safeguarding performance - this is a new priority

At our Board meeting on 16th May 2024 we welcomed new Board members from Derbyshire Police, Cloverleaf Advocacy and HMP Sudbury. I would like to take this opportunity to thank Darren De'Ath, our previous Board member for Derbyshire Police, who has now moved to a new role. Darren has made a significant contribution to the Board and Core Business Group over the past few years and I wish him all the best.

News from the Board

The DSAB meets every three months and the last meeting took place on 16th May 2023

Below is a summary of the items discussed at the meeting:

- A new animation was shown to Board members to share the learning from William's Story (SAR22A). The animation was produced by Derbyshire Police and the DSAB Board Manager.
 - The DSAB terms of reference for 2024/2025 were agreed.
 - The DSAB Strategic Plan for 2024/2025 was agreed.
 - The updated DSAB Risk register was discussed and further discussions will take place at the next Derby and Derbyshire SABs Core Business Group meeting.
 - Sub-group updates were provided by sub-group chairs in relation to progress and challenges.
 - Derbyshire County Council Adult Social Care presented key headlines from the quarter 4 safeguarding adults data.
 - A presentation was delivered by Probation in relation to the changes being made in order to strengthen capacity to support offenders in the community.

VARM Hoarding Grant 2024/2025



From 1 April 2024 the VARM Hoarding Grant is available for 2024/2025

The total funds available for 2024/2025 is £15,000, so we have to ensure it is used to support those in most need. The maximum application per household is £600.

With this in mind and before submitting a VARM Hoarding Grant application, please consider other funding streams that may be able to support adults who are at risk due to hoarding in their home. A list of [benevolent funds and charitable funding](#) is available from the Derbyshire Safeguarding Adults Board website.

Please note these are likely to have particular criteria that need to be met for funding to be considered.

Self-neglect toolkit and case closure checklist



The Derby and Derbyshire Safeguarding Adults Boards self-neglect toolkit and case closure checklist is now available

Self-neglect can be a complex and difficult area of work for practitioners. The [Derby and Derbyshire self-neglect toolkit and case closure checklist](#) has been produced to support practitioners working with adults in Derby and Derbyshire who have been referred for adult safeguarding support due to self-neglect concerns.

Practitioners should continue to refer to the self-neglect section of the [Derbyshire and Derby Safeguarding Adults Board Decision Making Guidance](#) alongside this toolkit to ensure they have a clear understanding of the level of risk. The Care Act 2014 recognises self-neglect as a category of abuse and neglect.

Who is the self-neglect toolkit for?

All practitioners and managers working for agencies in Derby and Derbyshire who support adults in complex self-neglect situations.

What is the self-neglect toolkit designed to do?

The self-neglect toolkit aims to:

- Provide suggestions about what can be done when working with adults who self-neglect
- Make sure that you, and all the other agencies you work with, have tried everything you possibly can to safeguard the adult prior to closing involvement
- Help you to understand how working with other agencies can improve outcomes for adults who self-neglect

Safeguarding Adult Review SAR22A 'William' publication



The Derbyshire Safeguarding Adults Board (DSAB) commissioned a Safeguarding Adult Review (SAR) in 2022 in accordance with the Care Act 2014 in relation to the sad death of an adult who we refer to as William in order to protect his identity.

William died following a fall at his home. Prior to his death, concerns had been raised about the risk of harm posed to William, due to him living in circumstances of self-neglect.

The SAR is now complete, and a [Learning Brief and Learning On One Page \(LOOP\)](#) have been published on the DSAB website to provide an overview of the circumstances, findings, good practice, and recommendations.

Three recommendations were made in this SAR and work is well underway to ensure that the learning makes a difference to the support we provide to adults living in similar circumstances to William in the future. This includes the recent launch of a brand new [self-neglect toolkit](#) for front line staff and managers across all agencies to support them to achieve the best possible outcomes when working with adults who are at risk of harm due to self-neglect.

The Board will continue to monitor progress and seek assurance that the learning from this SAR is fully implemented.

Multiple Exclusion Homelessness: A safeguarding toolkit for practitioners

The intention of the [Multiple Exclusion Homelessness safeguarding toolkit](#) is to provide practitioners with a helpful resource to aid fact finding and decision-making in the context of adults experiencing

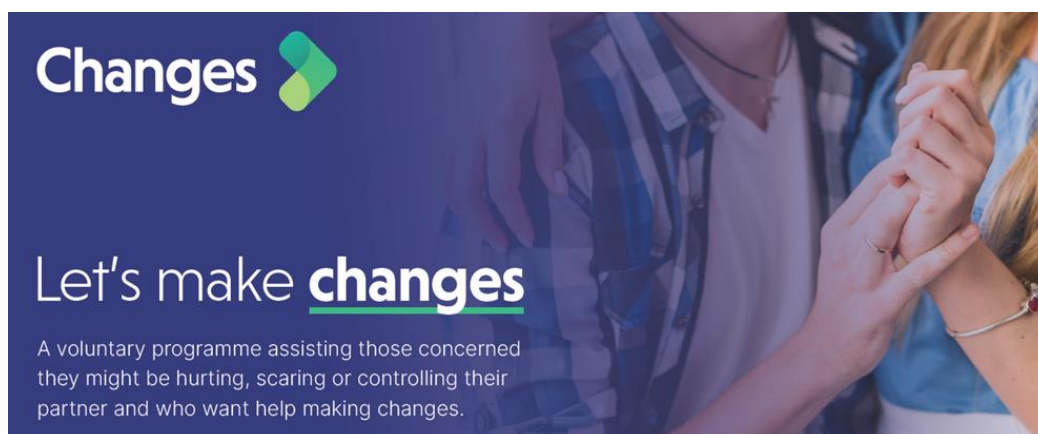
multiple exclusion homelessness. It can be used as an aid to communication and multidisciplinary working across sector boundaries.

The toolkit underscores the principle that safeguarding is a collective responsibility. It equips practitioners with the necessary guidance to actively gather information, unveiling risks that may otherwise be overshadowed by complexity or immediate crises.

Divided into four pivotal sections – assessing needs and risks, chronicling events, identifying immediate risks, and devising protection plans – the toolkit integrates invaluable resources, links, and nuanced guidance for practitioners to consider in reaching conclusions.

Let's Make Changes: A Programme Transforming Lives and Relationships



In a bid to create a safer environment for victims of domestic abuse and their children in Derbyshire, the Changes programme offers assistance to individuals who recognise that they may be causing harm, fear, or control within their relationships. This initiative aims to foster social change, promote respectful relationships, and hold perpetrators accountable while delivering a coordinated response to domestic abuse.

Project Objectives

- Increase safety for victims of domestic abuse and their children
- Assess and manage risk
- Support social change
- Provide services to diverse communities
- Promote respectful relationships
- Hold perpetrators accountable
- Deliver a coordinated response
- Evaluation and development

For Partners & Ex-Partners

This free, voluntary programme emphasises that everyone faces challenges in relationships, and external pressures can impact behaviour. However, it underscores that no one has the right to engage in harmful or intimidating actions. Whether it's a current partner or an ex-partner, Changes helps individuals make positive changes in their lives.

For Professionals

Professionals are encouraged to reach out if they suspect someone is mistreating their partner. The Changes programme is a voluntary initiative providing support to those concerned about their behaviour and wanting help to make positive changes.

Referral Information

Referrals are accepted from various sources, including self-referrals. Criteria for referral include individuals over 18 using violent and abusive behaviour toward their partners/ex-partners, showing recognition of their abusive behaviour, and a willingness to change. Individuals cannot be on bail, under investigation, or going through family court.

Seeking Change

The programme recognises that relationships can be challenging and may lead to harmful behaviours. It offers free one-to-one assessments, individual and group-work sessions to help people understand relationship difficulties, take responsibility for abusive behaviour, and make positive changes for themselves and their partners or ex-partners.

Project Providers

The Changes project is managed and delivered by a consortium comprising three specialist domestic abuse support providers: The Elm Foundation, Crossroads Derbyshire, and Derbyshire WISH Domestic Abuse Services. Together, they cover the entirety of Derbyshire, providing intervention, guidance, and support to referred individuals.

The new all-age Carers service has been designed to deliver the Derbyshire Carers Strategy by ensuring Young Carers, Young Adult Carers and Adult Carers have access to preventative, timely, appropriate and person-centred support.

Features of the new Derbyshire All Age Carers Service include:

Early Identification and Support

To promote early identification and encourage Carers to self-identify, we will raise awareness of the caring role, the rights of Carers and the support that is available at an individual, organisational and strategic level.

Healthcare Liaison will deliver support, advice and training to health service teams to improve the way Carers are identified and supported.

Information and Advice

Carers can access information and advice in a variety of methods that is accessible and appropriate for their needs. This includes our Carer Helpline, online resources and learning programmes.

Carers will be well informed throughout their caring journey about the support available to them in their role, their rights and how to support their individual wellbeing. Learning sessions will include 'new to caring' and 'planning for the future' workshops.

Recognising and Supporting Carers in the Wider Community

We will develop quality partnerships across all communities to proactively identify, connect and support carers, and ensure the service supports a diversity of communities.

Our network of Carer Champions from across all sectors and communities will receive ongoing support and resources to identify and connect Carers from hidden and diverse communities.

Involving Carers as Experts

All age Carers will be involved in the design and evaluation of the service through our Carers Voice project. We will consult with Carers on issues which are important to them and share our findings and recommendations with partners.

Services and Systems That Work for Carers

Locality teams will support Carers to navigate and connect with services for themselves and the person who they care for. Through affiliation with Carefree and the Carers Trust, we will help Carers access resources and a break from caring.

The Derbyshire County Council Carer Liaison Worker will be integrated within our team to ensure a cohesive, consistent, whole family practice between Adult Social Care, Children's Services, and the Carer service.

Carer Employment and Financial Wellbeing

Our Carers in Employment programme will support workplaces and promote best practice in relation to their own workforce who are carers. We will introduce employer training and quality awards. We will host monthly legal and financial clinics and explore ways to promote income maximisation for all Carers.

Innovation

Through local, regional and national networking and our established partnership with the University of Derby, we will continually explore best practice and how this can be integrated within services in Derbyshire. We will source additional income for new areas of work that will be co-produced with Carers.

Derbyshire Young Carers – for Children and Young People Aged 5-16

Reducing inappropriate caring pressures that may have an impact on a child or young person's development.

- One-to-one sessions with a Young Carers Support Worker
- Young Carer Assessment and Support Planning
- Family support sessions
- Support within school
- Age appropriate groups, workshops and family activities
- Helpline available Monday to Friday 9am-5pm

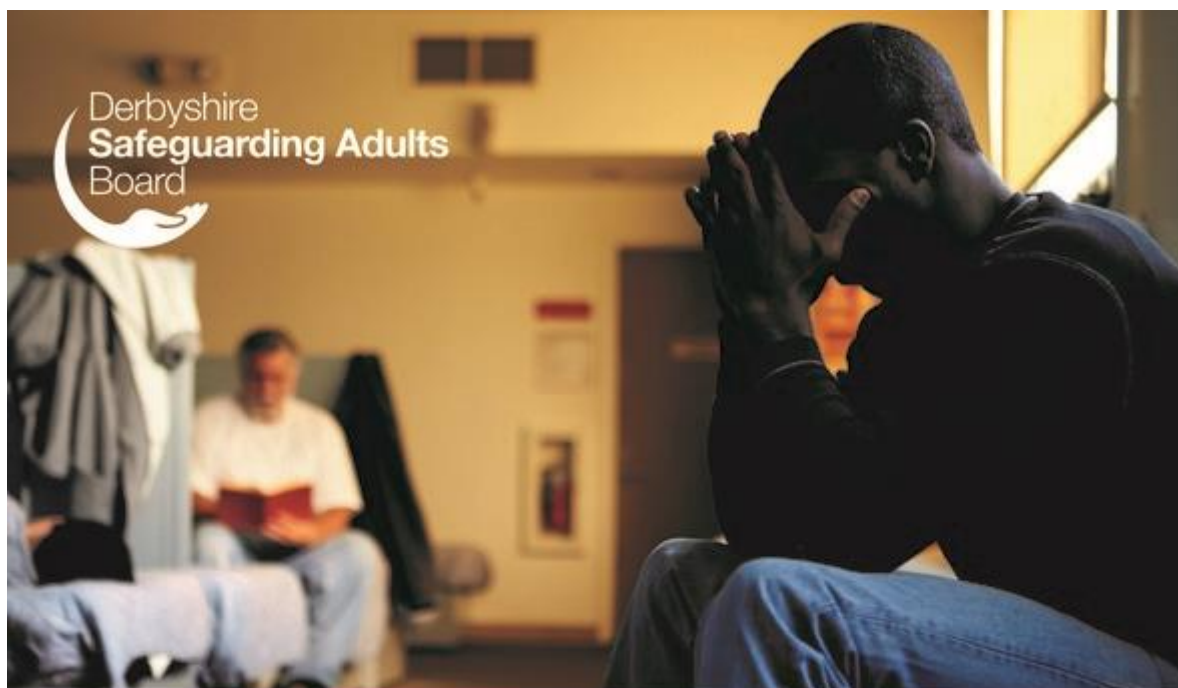
