The Derbyshire Safeguarding Adults Board (DSAB) meets every three months and the last meeting took place on 10th April 2025


The Derbyshire Safeguarding Adults Board (DSAB) has met twice since our last newsletter. An extraordinary Board meeting took place on 11th March 2025 to discuss the report and recommendations for a Safeguarding Adult Review, SAR23A. The sign off process is almost complete and once final sign off has been confirmed, plans to disseminate and share the learning will be agreed and shared.

A Board meeting also took place on 10th April 2025 in the form of a joint development session with Derby Safeguarding Adults Board. The session focussed on Board achievements over the past twelve months and then looked forward to the work needed to achieve the new strategic plan for 2025-2028, which will be launched soon. Board members discussed the priority areas of focus for the Boards to achieve their objectives and also discussed the importance of accountability and the role of a Board member in ensuring that the Board is effective. The feedback from the session has been valuable, and further work is being undertaken to review suggestions and feedback from the session. The latest version of the Derby and Derbyshire Safeguarding Adults Policy and Procedures document is always available on the Derbyshire safeguarding Adults Board website.




NEW - Derby and Derbyshire Safeguarding Adults Equality, Diversity and Inclusion Charter



The <u>Derby and Derbyshire Safeguarding Adults</u> <u>Equality, Diversity and Inclusion Charter</u> outlines clear and accessible information about equality, diversity and inclusion (EDI), along with the commitments in this area by the safeguarding adults boards.

The document was officially launched at the recent joint Derby and Derbyshire Safeguarding Adults Boards Development Day, where Board members who attended were invited to sign-up to the Charter.

NEW - Meeting titles and acronyms crib sheet



When it comes to meetings, are you sure it's the right type and that you're clear about its aims?

To help, we've put together a <u>meetings titles</u> and acronyms crib sheet. It gives the full names of meetings and their commonly-used acronyms, along with a description and their purpose.

NEW - Lasting Power of Attorney (LPA) posters

A lasting power of attorney (LPA) is a legal document which allows a person to give people they trust the authority to manage their affairs if they lack capacity to make certain decisions for themselves in the future.

To set up an LPA a person must be 18 or over, and have the mental capacity to decide to do so. The person the LPA is set up for is known as the donor.

The person chosen to make decision on behalf of the donor is known as the attorney. The attorney must also be over 18 and must themselves have the mental capacity to act as an attorney. For property and financial affairs LPAs, the attorney must not be bankrupt.

There are two types of LPA:

- health and welfare
- property and financial affairs

Do you know you can choose someone you trust to make decisions for you, if you aren't able to

There may come a time when it is difficult to make decisions.

It's your life and your choice...protect your future.

There is an incorrect commonly-held belief that being someone's near relative gives you the right to make decisions on their behalf, should they lose mental capacity. In law, the term 'next of kin' has no legal basis, which is why advance decisions wrapped up within LPAs are important to ensure a person's wishes are carried out.

SCIE (Social Care Institute for Excellence) has more information about LPAs.

The <u>National Mental Capacity Forum</u> is a joint Ministry of Justice and Department of Health and Social Care initiative. Its purpose is to work with stakeholders from health and social care, together with those from other sectors (for example, finance, legal, police, housing) to identify complementary actions which member organisations can pursue, especially at a local level, to improve implementation of the MCA.

Safeguarding: What to Expect leaflet language translations

Our <u>Safeguarding: What to Expect leaflet</u> provides an explanation of the purpose of the safeguarding process in a clear and straightforward way.

The leaflet is something that can be 'owned' by the person and they can refer back at any point during the safeguarding process.

The leaflet contains sections where the practitioner can inform the person who their key point of contact is in relation to the safeguarding process and the nature of the concerns raised about them.


There is also a section where the person can write down any questions, wishes or feelings. This information can be used as part of safety planning to ensure that the person's views have been taken into account.

Multiagency Adult Risk Management: What to Expect leaflet language translations



The <u>Multiagency Adult Risk Management: What to Expect leaflet</u> will help the person you are supporting understand why a MARM meeting has been arranged.

There is a section in the leaflet for the person to write down their views, wishes and feelings, and it can be used as a way for them to contribute to the MARM process if they do not wish to attend the meeting, or to support discussions at the meeting if they do attend.

Where possible, the leaflet should be shared with the person you are supporting at the start of the process.

When to consider making a Safeguarding Adult Review referral



What is a Safeguarding Adult Review?

Section 44 of the Care Act 2014 requires local Safeguarding Adult Boards to arrange a Safeguarding Adult Review (SAR) when an adult in its area dies as a result of abuse or neglect, whether known or suspected, and there is concern that partner agencies could have worked more effectively to protect the person at risk.

A SAR must also be conducted when an adult has not died, but the Board knows or suspects that the adult has experienced serious abuse/neglect. In the context of SARs, this would include situations where a person would have been likely to have died but for an intervention, or has suffered permanent harm, or has reduced capacity or quality of life (whether because of physical or psychological effects) as a result of the abuse or neglect.

Safeguarding Adult Review criteria

Section 44 of the Care Act 2014 states that the Safeguarding Adults Board is the only body that can commission a SAR and it **must** arrange a SAR if:

- The case involves an adult in the Derbyshire area with care and support needs (whether or not the Local Authority was meeting those needs); and
- There is reasonable cause for concern about how the Safeguarding Adults Board, its members or other persons with relevant functions worked together to safeguard the adult.

AND

• The person died (including death by suicide) and the SAB knows or suspects that the death resulted from abuse or neglect (whether or not it knew about or suspected the abuse or neglect before the person died).

OR

The person is still alive, but the Safeguarding Adults Board knows or suspects that they have experienced serious abuse or neglect. The DSAB will only consider cases in its area in accordance with its obligations under s.44 of the Care Act 2014.

When to consider making a SAR referral

Any practitioner or manager may become aware of a serious incident or death which appears to meet the above SAR criteria. The first step is to discuss the circumstances with your safeguarding lead/manager so that they can decide whether a SAR referral should be made.

Your safeguarding lead may ask you to provide information for the SAR referral, or ask you to complete the referral form, but they will approve the content and submit it to the DSAB.

Making referrals to the Safeguarding Adult Reviews Sub-Group

A SAR referral can be made by any DSAB partner organisation via their safeguarding Lead or Board member. The referral should be made using the DSAB <u>SAR referral form</u>, which should be submitted to the DSAB office, email <u>DerbyshireSAB@derbyshire.gov.uk</u>. On receipt of the SAR referral, the SAR Sub-Group Chair will screen the referral and, if required, arrange a meeting with the referrer for a follow up discussion.

If the referral does not evidence why the SAR criteria have been met, the SAR Sub-Group Chair may ask the referrer for additional information. If the referral does not provide sufficient information to justify consideration by the SAR Sub-Group, the referrer will be informed, and the case will not be considered by the SAR Sub-Group.

If the SAR criteria appear to have been met, the referral will be considered by the SAR Sub-Group at the group's next scheduled meeting, which are held quarterly. The referrer will be asked to attend the meeting to present the referral.

The SAR referrer will be notified of the outcome of the discussions and whether a SAR is commissioned.

Where to find information about SARs

The DSAB website has a <u>Safeguarding Adult Reviews page</u>, which contains learning resources from Derbyshire SARs as well as the DSAB SAR protocol, and the SAR referral form.

The National SAR library contains SARs published by Safeguarding Adult Boards across the country.

Professional curiosity



Applying professional curiosity can help practitioners to identify the less obvious signs of abuse and neglect

Professional curiosity is looking, listening, asking questions, checking out information, and reflecting on information received. It means being curious and seeking clarity around a situation, bringing together information

from different sources to gain a better understanding of a person's circumstances and level of risk.

Your Journey – sexual violence: a survivor's guide to support and reporting


"Your Journey – sexual violence a survivor's guide to support and reporting" has been launched in Derbyshire

First launched in February 2020, *Your Journey* was written by Nottingham-based Consent Coalition, with input from survivors.

It gently looks at the decisions a person might make following an incident of sexual violence. This includes sections on:

- Specialist support services
- Decisions, choices and options
- Myth busting
- Independent Sexual Violence Advisors (ISVA)
- Reporting to the Police
- Sexual Assault Referral Centre (SARC)
- Police investigations
- Criminal justice process

If you or someone you know in Derbyshire is being abused or neglected please tell someone. In an emergency, contact the Police, tel: 999 or if you are deaf/hard of hearing use emergency SMS by texting 999 from your phone, or use the NGT Relay Assistant by dialling 18000 from the app or textphone.

If the person is not in any danger now but there has been a crime, contact the Police, tel: 101. If you're worried about yourself or someone else being abuse or neglected, please contact Call Derbyshire, tel: 01629 533190.
