News from the Board

The Derbyshire Safeguarding Adults Board (DSAB) meets every three months and the last meeting took place on 10th July 2025

Below is a summary of the items discussed at the meeting:

- The Board welcomed attendance from Kara Gratton, Milford Care who is supporting the Board to improve links across the care home sector in Derbyshire.
- A safeguarding adult review report for SAR24A was presented to Board members. Board
 members agreed the report and findings and work is now underway to produce an action plan to
 show how the learning will be embedded.
- An update was provided by Derby and Derbyshire ICB in relation to structural changes within the organisation.
- Board members were made aware of the announcement for Healthwatch England and local Healthwatch organisations to be closed.
- The DSAB's 2025-2028 Strategic Plan, one page summary and easy read version of the plan were shared with Board members.
- An update was provided on the work undertaken to respond to the recommendations made in a ministerial letter sent to safeguarding adults boards in relation to people who are homeless.
- The risk register was reviewed, and updates were agreed.
- Subgroup chairs provided updates on activity undertaken by their subgroup over the previous quarter and it was agreed following review of workplans that two subgroups, Learning and Development and Mental Capacity Act, would be disbanded.

- The Multiagency Adult Risk Management (MARM) annual report 2024-2025 was shared
- Safeguarding adult performance data was shared by Derbyshire County Council adult social care.

Strategic Plan 2025-2028



It is a statutory requirement of all safeguarding adults boards to produce and publish a strategic plan.

The Derbyshire Safeguarding Adults Board's (DSAB) strategic plan for 2025-2028 outlines our vision and mission, and our three strategic priorities: prevention, inclusion, and performance. It also shares how we will measure the impact of the work we undertake, as well as providing information about the current governance structure in place for the DSAB.

We would like to thank Derbyshire County Council Adult Social Care's Stakeholder Engagement and Consultation Team (SECT) who co-produced the easy-read version with support from one of their ambassadors.

There is an action plan in place to support and inform the DSAB's subgroups of the priority areas of work required. The action plan will be regularly reviewed and updated by the DSAB. Each subgroup has its own business plan in place to outline how they will implement the plan and achieve its objectives, and these plans are reviewed quarterly.

NEW - Equality, diversity and inclusion, and safeguarding adults practice guidance

The Derby and Derbyshire Safeguarding Adults practice guidance document now includes a new section about the importance of ensuring that there is due regard to equality, diversity, and inclusion throughout all safeguarding adults practice and activity.

In the guidance there is a checklist for practitioners and

managers. The list provides areas for consideration when working with people from diverse communities and backgrounds.



Equality, diversity, and inclusion (EDI) are fundamental principles when working to safeguard people from abuse and neglect.

Front line staff and managers across Safeguarding Adult Board partner agencies play a crucial role in ensuring that these principles are embedded in their practice to protect adults at risk effectively.

- Equality involves ensuring that every person has an equal opportunity to make the most of their lives. It means that no-one is disadvantaged because of their background or characteristics.
- Diversity acknowledges and values the full range of differences between people in the community, including race, ethnicity, gender, age, disability, sexual orientation, and religion.
- Inclusion ensures that all people feel respected, valued, and able to contribute fully to society.

The Derby and Derbyshire Safeguarding Adults Practice Guidance document now includes a section about applying equality, diversity, and inclusion while safeguarding adults.

UPDATES - Derby and Derbyshire Safeguarding Adults practice guidance

World Elder Abuse Awareness Day 2025




World Elder Abuse Awareness Day is on 15th June each year, and to mark the day this year, Derbyshire Safeguarding Adults Board hosted two webinars on 16th June 2025.

Training was delivered to raise awareness and support staff to recognise the signs of domestic abuse and sexual abuse of older people and learn about the support available locally. Ninety-eight staff members from across thirteen partner agencies received the training.

Trauma Informed Derbyshire online learning and resources



Trauma Informed Derbyshire is the title of a programme of work being led by Derbyshire's Public Health department, to support and accelerate knowledge across the system about the impact of trauma across the life course.

The vision is to build a trauma-informed workforce that is able to recognise the impacts of trauma and respond in ways that promote recovery – overall reduce inequalities and increase the life chances for all who reside and work in Derbyshire.

With an overarching aim that by being trauma-informed, we can better support those affected by trauma and champion the breaking of long-term cycles of deprivation, discrimination, and inequality.

Lizzie Watt, who is the Public health Lead for Trauma Informed Derbyshire, is delighted to share information about how to access the 3-part online **Trauma Informed Derbyshire – Foundation Learning**.

The learning is designed to be done individually or as a group – it is recommended to work through the modules in a group, where possible. There are many 'pause' moments where sharing thoughts will stimulate rich discussion. There is a 4th module which offers guidance for anyone leading group learning. It is recommended you do the 3 modules in order, but you are free to approach as suits you best. There is an accompanying workbook for each module which can be written into online or downloaded and printed.

"How long will each module take?" you may ask – that depends on how you approach this resource and how much time you have available. Each module plays as a video that lasts around an hour but is 'chunked' into bitesize sections. These allow for shorter learning sessions which, for example, could be added into your team meetings. The sections allow you to pause when you want to discuss things further or consider an issue of particular interest to your context.

- **Get started** follow the instructions in the downloadable <u>step-by-step guide</u> that explains how to access the Learning Pathway. You will need to <u>create an account</u> to access the resource. Your account is your gateway to accessing the 3 modules and accompanying resources.
- Share with your colleagues A short trailer is available to explain the resource.
- **Give your feedback** completing the survey at the end of each module will really help with understanding the impact of this resource.
- Remember you can dip into the 3 modules at any point and as often as you want. Your unique pathway will remember what you have completed to date and let you go backwards and forwards as often as you need.

Guidance to support implementation of the Mental Capacity Act in acute trusts for adults with a learning disability





NHS England has published <u>guidance to support</u> <u>implementation of the Mental Capacity Act in acute trusts for adults with a learning disability.</u>

This guidance supports trusts and community providers in enabling frontline staff to fulfil their legal requirements under the Mental Capacity Act (MCA) 2005, specifically when supporting people with a learning disability.

The MCA provides the legal framework within which decisions can be made on behalf of a person aged 16 or over in England or Wales who lacks the capacity to make those decisions for themselves.

Capacity is both time and decision specific and should be assessed whenever there is a reason to doubt an individual's ability to make a specific decision at a specific time.

Decisions about a person's capacity are not based on their condition. Every effort must be made to support a person to be able to decide themselves whether to consent or not to treatment and care. This may mean making reasonable adjustments in assessing capacity for people with a learning disability; these can be crucial.

If a person is found to lack the capacity to make a specific decision in a specific timeframe, any decision made on their behalf must be in their best interests in line with the MCA. Any best interests decision must be properly recorded in the clinical notes.

Derbyshire Fire and Rescue Service Carers Sticker

Derbyshire Fire and Rescue Service (DFRS) visit thousands of homes each year, offering tailored fire safety advice to some of the most vulnerable members of our community. Many of the people they support rely on carers, friends, and family for assistance in their daily lives.

DFRS understand how busy carers can be, and that it may not always be possible to join them during their visits. To help make sure important fire safety information reaches everyone involved in caring for an individual, DFRS have developed a new initiative — the Carers Sticker.

You may notice the Carers Sticker displayed in the home of your friend or family member after DFRS have visited. DFRS's officers use these stickers to pass on essential fire safety advice and practical steps that

carers can take to help keep their loved ones safe. The sticker also contains DFRS's contact information, making it easy to get in touch if you need further guidance or have any additional fire safety concerns.

In addition to home visits, Derbyshire Fire and Rescue Service also offers a free online <u>DIY Home Fire</u> <u>Safety Check</u>, which takes just 15 minutes to complete. It's a simple and effective way to spot fire hazards and improve safety at home.

If you are concerned about someone you care for, please don't hesitate to contact DFRS. You can arrange a Safe and Well visit from one of our team members by contacting us directly on the numbers provided.

Together, we can help keep Derbyshire's most vulnerable residents safe from fire.

There is no excuse for abuse

If you or someone you know in Derbyshire is being abused or neglected please tell someone.

In an emergency, contact the Police, tel: 999 or if you are deaf/hard of hearing use emergency SMS by texting 999 from your phone, or use the NGT Relay Assistant by dialling 18000 from the app or textphone.

If the person is not in any danger now but there has been a crime, contact the Police, tel: 101.

If you're worried about yourself or someone else being abuse or neglected, please contact Call Derbyshire, tel: 01629 533190.
